Österreichs Hotels dürfen Ende Mai wieder öffnen: Österreich bereitet sich auf eine Rückkehr der Urlauber vor. Laut Tourismusministerin Elisabeth Köstinger dürfen die Hotels im Nachbarland am 29. Mai wieder für private Übernachtungen öffnen. Auch touristische

Sehenswürdigkeiten können dann wieder den Betrieb aufnehmen. Voraussetzung ist, dass der Mindestabstand von einem Meter eingehalten werden kann. In Indoor-Bereichen muss zusätzlich ein Mund-Nasen-Schutz getragen werden, und es müssen pro Besucher mindestens zehn Quadratmeter Platz zur Verfügung stehen. Während Schwimmbäder und Freizeitanlagen ebenfalls am 29. Mai wieder öffnen können, dürfen Tierparks und die Gastronomie bereits ab 15. Mai wieder Gäste empfangen. Allerdings unter Auflagen. Zum Beispiel dürfen in Gaststätten und Restaurants maximal vier Erwachsene plus Kinder an einen Tisch. Zwischen den Tischen muss ein genügend großer Abstand sein. Und das Servicepersonal muss einen Mund-Nasen-Schutz tragen.

Austria's hotels will reopen at the end of May: Austria is preparing for a return of holidaymakers. According to Minister of Tourism Elisabeth Köstinger, hotels in the neighbouring country may reopen for private overnight stays on 29 May. Tourist attractions will then also be able to resume operations. The condition is that the minimum distance of one metre can be maintained. In indoor areas, an additional mouth and nose protector must be worn and at least ten square metres of space must be available per visitor. While swimming pools and recreational facilities can also reopen on 29 May, zoos and the catering trade are allowed to welcome guests again from 15 May. However, this is subject to conditions. For example, in pubs and restaurants a maximum of four adults plus children are allowed at a table. There must be a sufficient distance between the tables. And the service staff must wear a mouth and nose protector.

Please **imagine** also – these few **examples**:

... at the French Boarder: German, Swiss and others would just show their car ferry ticket for Irish Ferrys Cherbourg-Dublin route and are therefore allowed to pass through... (weil das ein „triftiger Grund ist“)
(Until 2 weeks ago we were quite successful in getting many of our individuall car ferry holiday makers to postpone their trip into later this year. Now: 2-6 cancellations every day... I'm getting nervous. No comment on our many cancelled groups – a financial desaster)

... Irish Government orders Aer Lingus and Ryanair to install a first (weekly?) series of Charterflights from selected European Airports – best into western airports (SNN, NOC, CFN, ORK..). At heavily reduced prices – along with scientific research. Not meant for big, cheap groups but for individuals who would have to pass a small „test“ (Fit for this Island?)

... „the Government“ has convinced the European Tourism Ministers (on their meeting on Monday, 27.4. – nobody knew about it?) to establish a European database of service providers (B&Bs, hotels, camping, sights..) sorted after state/country. Enableing every business to produce some basics. Mainly: open, yes, no, when, etc.. . So avoiding thousands of Google and other Internet request, giving evrybody a chance to let „Europa“ know...

... „the Government“ would, on a 2 (?) weeks intervall, inform all relevant trade partner (organisations) on the current situation, outlook etc..

In the case of tourism it could contain messages such as: „We are working on different scenarios, have various advertisement campaigns ready to select from (Ireland has now openedfor you!“), have read papers such as

Not happy about that what's going on in Germany: state bodies throwing out money - spending so many billions and billions for in parts very wrong people/ companies/clientele.

Not happy about the new „German tourism experts“ such as EU lady Ursula von der Leyen („Sorry, no summer holidays this year“ or Heiko Maas (Minister for foreign affairs; saying: „wordwide travel warning will have to be lenghened“ – **not making any differentiations between states/countries. Now in place: until June, 14. Unbelievable.**

Not happy about „Ireland“ either: no proper, regular information. One needs to check the internet almost dayly instead of a central newsletter to all of us.

I know from some Irish friends that they „feel totally lost“ also. Car Ferry Companies and Airlines being only a bit better.

Hard times to stay friends.

In our thoughts we have already made 35 submissions, made 81 suggestions and have written 17 letters to the editor. We think that it would be as easy as it is cautious to start a new "post"-Corrona tourism drive into the rural the regions, which is so necessary...
